- Eligible Art** This competition is open to original works of art whose primary component is fiber. Artists may enter up to three (3) pieces of work per category, with separate application and entry fee for each entry.
- Categories** Wearable, 2-Dimensional, 3-Dimensional
- Prizes will be issued for:**
- Best of Show \$200.00
 - 1st Place Each Category \$100.00
 - 2nd Place Each Category \$ 50.00
- Application/Art Delivery** October 28 & October 29. All work must be delivered between 9:00 am – 5:00 pm. A completed application form, entry fee and artist statement/bio must accompany each entry. **No late entries allowed.**
- Opening Reception** Friday, November 5 from 5:30 – 8:00 pm. The reception – and the exhibition – are free and open to the public.
- Show Closes** Saturday, November 26.
- Art Pick-Up** All work must be picked up between Tuesday, November 29 and Wednesday, November 30 from 9:00 am – 5:00 pm. Artwork not picked up by December 18 will become property of The Arts Council of Henderson County.
Note: *Special arrangements for other pick-up dates will be considered by calling (828) 693-8504 before the close of the exhibition.*
- Gallery Hours** Tuesday through Friday 1:00 – 5:00 pm
Saturday 1:00 – 4:00 pm

Jury and Judging Show

- All artwork entries will be juried. If your work is selected, it will then be displayed and judged. If your work is not accepted by the Jury, you will be notified by email or phone. All work not accepted must be picked up between November 8 and November 10, 9:00 am – 5:00 pm or it will become property of The Arts Council of Henderson County.

Category Definitions

- **Wearable** – Original design garments, scarves, shawls, purses, jewelry, liturgical, etc.
- **2-Dimensional** – Original design weavings, rugs, quilts, and other 2-D work. 2-D art may be textured or have some dimensionality as long as it designed to be hung on a wall or laid flat on a bed or floor.
- **3-Dimensional** – original design basketry, dolls, sculpture and other 3-D work designed to be displayed as free-standing art not requiring support from a wall or similar vertical surface.

Art Requirements/Jury Criteria

- Artwork must have been created within the last two years.
- All artwork must be delivered ready to display. Framed pieces must be wired. Quilts and other “soft” wall art must include a hanging sleeve with rod which can be wire-wrapped for hanging.
- All artwork must be for sale and priced accordingly.
- All artwork must be of original design.
- All artwork must be created by the artist. (No construction from purchased patterns, pieces or kits.)
- All artwork must be produced solely by the artist/s; however, in the case of quilts, quilting done by a paid quilting service is allowed, but must be noted on the entry form. Collaboration of two or more artists is permitted. Artwork designed by the artist and “manufactured/produced” by other workers/assistants is not permitted.
- Due to space limitations, size of artwork (especially 2-D wall art and quilts) will be a factor in jurying.
- Artists may enter more than one piece in a category provided a separate application and fee is received for each entry.
- Artists may enter artwork in more than one category, provided a separate application and fee is received for each entry.
- A completed application form, artist statement/bio and entry fee must accompany each piece of artwork submitted.

Waiver of Liability

All reasonable care will be taken with artwork. Artists must sign a waiver of liability at time of delivery.

Application Fee

- \$20 fee per entry.
- Arts Council of Henderson County Members will pay no fee for the first entry and will pay \$10 for each subsequent piece entered.

Commission

- The Arts Council of Henderson County receives a 30% commission on all sales.
- All exhibited artwork will be marked with the price set by the artist.

Photographic Rights

- The Arts Council of Henderson County reserves the right to photograph the show for the purposes of documentation, education and publicity.

All exhibiting artists will be listed on the Arts Council website and included in the publicity campaign. Artist's website will be linked from the "Fiber Art" listing in the "Calendar of Events" page on the Council's website.
