Arts Council of Henderson County Member Show @ Toe River Arts Council is a juried show that is part of a reciprocal relationship with the Toe River Arts Council, and follows *The Artists of Toe River* exhibition hosted by the Arts Council of Henderson County in October 2010.

Artist Eligibility: Must be a member in good standing of The Arts Council of Henderson County; residency in Henderson County is not required. *Annual artist memberships are \$40 and \$60 (for enhanced membership which includes web links).* Member artists will be selected by a call to artist members to participate in this juried traveling exhibition.

Artists not selected to be in the exhibition will be notified by phone or email on Thursday, April 21; work can be picked up at the Arts Council of Henderson County the week of April 25 – 29 between 10:00 am – 4:00 pm. Work not picked up by May 31 may become the property of the Arts Council.

- Fees:** **\$10 per each piece submitted** (non-refundable). (Entry fee amount will cover ACHC transport costs.)
Artists may enter a maximum of 2 pieces.
- Commission:** The Toe River Arts Council will receive a 40% commission on all work sold and will issue payment within 15 days of the close of the exhibition. The Arts Council of Henderson County will not charge an additional commission.
- Media:** All media accepted.
Maximum canvas or image size is 4' x 4'.
All art must be available for purchase.
Work cannot be more than two years old.
Work must be original (no prints or reproductions), except for photography or digital art.
Work must be largely created by the artist. (No construction from purchased pieces or kits.)
Work must be produced solely by the artist. (May be a collaboration of two or more artists, but not designed by artist and "manufactured" by other workers.)
Size of art (especially 2-D wall art) may be significant in decision-making process.
All 3D work will be exhibited on pedestals as appropriate. All large sculpture must be able to stand alone or come with a support system included. If you have questions about the acceptable size for large sculptures please contact us.
- Transportation:** ACHC will be responsible for transporting art to and from venue location. Artists will be responsible for proper packaging of their art for transport. ACHC reserves the right to refuse artwork that is inadequately prepared for transport.
- Labels:** *Each piece must have the following information attached: **Artist Name, Title, Medium, Price.** There is a form below the application that you may cut and attach.*

*Artist may provide a print or electronic version (Word format) of artist statement, biography and any additional information requested. **This is optional, but highly recommended.***

Liability

*All reasonable care will be taken with the art; work is entered at the risk of the artist. Neither the Arts Council of Henderson County, nor the Toe River Arts Council, nor their representatives and volunteers can be held responsible for any loss or damage to your work from any cause. Submitting a work of art shall imply an agreement on the part of the artist to the conditions set forth in this prospectus. **Artists will be asked to sign a Waiver when art is delivered.***
